### **Spring Plenary**

The 2020 Spring Plenary Session will be taking place at the Oakland Marriott City Center from April 16th-18th, 2020.

#### **Transfer Webinar**

The Academic Senate for California Community Colleges, working in conjunction with the Intersegmental Committee of Academic Senates, is exploring the alignment of seven (7) existing Associate Degrees for Transfer (ADT) with existing UC Transfer Pathways (UCTP). The seven (7) proposed degrees are Anthropology, Business, Economics, History, Mathematics, Philosophy, and Sociology. During this webinar, the presenters will provide information about how each ADT aligns, or would align with a slight modification, to an existing UC Transfer Pathway.

The goal is for these aligned degrees to be included with the recently approved UCTP pilot degrees in chemistry and physics, as well as the potential alignment of engineering degrees between the CCCs and the UC systems. The alignment of chemistry, physics, and engineering requires legislative action to unite the two pathways at this time but input from discipline faculty across all systems clearly recommends the UCTP for chemistry, physics, and engineering. This would result in 10 aligned pathways clearly communicating to students the requirements for transfer to either of our intersegmental partners.

There will be two webinars: The <u>January 22, 2020</u> webinar will provide initial information and serve as a venue for attendees to ask questions and provide feedback on the provided draft alignments. The <u>February 4, 2020</u> webinar will be a follow-up to provide more information based on questions and feedback from the January 22 webinar.

### **Career & Noncredit Institute**

The ASCCC Career and Technical Education (CTE) Leadership and Noncredit Committees are pleased to announce the 2020 Career and Noncredit Education Institute designed for all faculty, ASCCC Liaisons, academic senates, student services professionals, administrators, and system partners.

### 2020 CIAC Annual Conference

Members of ASCCC's Guided Pathways Task Force (GPTF) are submitting a proposal to present at the upcoming California Intersegmental Articulation Council (CIAC) conference to discuss how Articulation Officers can and should be involved in local Guided Pathways (GP) efforts.

All 114 California community colleges are undergoing transformational change as they implement a GP framework. Two key elements of this process are the clustering of programs into related groups, often called "meta majors," and program mapping. Meta major organization and program mapping are curricular tools to help students streamline their navigation through educational choices.

It is important that articulation officers work with their college teams as meta majors and program maps are defined and evaluated for how they meet student needs. The ASCCC's Guided Pathways Taskforce (GPTF) will send a <u>resource team</u> to <u>visit colleges</u> upon invitation to help facilitate discussions around GP implementation and evaluation.

### Water & Wastewater Technology

We are pleased to announce that seven (7) new descriptors for Water & Wastewater Technology have been finalized. All current descriptors may be viewed on the C-ID website under the <u>Descriptors tab</u>, Articulation Officers may now submit Water & Wastewater Technology courses for C-ID approval!

### **Digital Media MC**

The Digital Media FDRG recently finalized seven (7) Model Curricula (MC) for a variety of Digital Media certificates, as well as four (4) new Digital Media descriptors. The MC may be viewed on the <u>Model Curriculum tab</u> of the C-ID website, and the descriptors may be view on the <u>Descriptors tab.</u>

It should be noted that model curriculum (MC) falls outside of SB 1440/440 and is not subject to the limits and mandates associated with such legislation. As a result, MCs will not obligate colleges to develop MC-aligned degrees or certificates. Each college may determine if the MC is appropriate for their program and students.
