# **GENERAL UPDATES**

## **Spring Plenary Recap**

At the 2019 Spring Plenary, the Academic Senate for California Community Colleges (ASCCC) celebrated 50 years of Leadership, Empowerment, and Voice. The ASCCC's Spring Plenary was held April 11-13, 2019 in Burlingame. During this session resolution 7.06 S19 Accelerate Review of Associate Degree for Transfer (ADT) Modifications was adopted. The resolution states "That the Academic Senate for California Community Colleges encourage the California Community Colleges Chancellor's Office to establish a process for fast tracking the approval of Associate Degrees for Transfer that have been minimally modified in a manner that is clearly consistent with the Transfer Model Curriculum upon which they are based."

### Career and Noncredit Institute - April 25-27

The ASCCC 2019 Career and Noncredit Education Institute was held April 25-27, 2019 at the DoubleTree by Hilton San Diego Mission Valley. The institute featured breakouts on many areas impacting noncredit and CTE education. Colleges were encouraged to send teams of practitioners and leaders, to include CTE Liaisons, career education faculty, noncredit faculty, counselors, senate presidents, and faculty and administrative leaders involved in career education, noncredit education, and the California Adult Education Block Grant (AEBG).

### **Submission Reminder**

C-ID would like to remind California Community Colleges that any substantial changes to a Course Outline of Record (COR), requires resubmission of that COR to C-ID. CORs must be resubmitted when a significant local change (course content; course objectives/SLOs; Prerequisites(s); Co-requisite(s); a unit change to less than the descriptor unit minimum) is made.

## **Economics 5-Year Review**

The Economics Faculty Discipline Review Group (FDRG), comprised of CCC and CSU faculty, recently met to discuss the results of the statewide vetting of the TMC and descriptors. Based on feedback provided, the FDRG is recommending revisions to List B of the TMC to include the option of any CSU GE introductory social science course. Additionally, the FDRG is recommending revisions to C-ID ECON 201 and ECON 202.

The purpose of reviewing the C-ID ISMC and descriptors on a 5-year cycle is:

- 1. To ensure that descriptors are current and reflect changes in the field that would necessarily impact curriculum
- 2. To provide an opportunity to revise elements of descriptors that were deemed problematic
